### PENALTY COMPUTATION

- A. For failure to file a return on time, with no tax due, the penalty is \$50.00.
- B. For failure to file a return on time with tax due, the penalty is:
  - 1-60 days late, 10% of the tax due for the first month plus 1% of the tax due for each month thereafter, but in no instance less than \$50.00, 61 or more days late, the greatest of the following:
  - i) 10% of the tax due for the first month plus 1% of the tax due for each month thereafter not to exceed 30% or
  - ii) the lesser of \$100.00 or 100% of the tax due, or
  - iii) \$50.00
