You must register to continue receiving the Basic STAR property tax exemption.

According to our records, you own the property identified above, and have been receiving a Basic STAR property tax exemption on it. The exemption application you originally filed with your local assessor does not satisfy this requirement.

If your 2023 income is more than \$250,000, but less than or equal to \$500,000, you may be eligible for the STAR credit instead of the STAR exemption. We will determine which benefit you qualify for once you register.

What to do next

- 1. Before you begin, have the following information available:
 - names and Social Security numbers for all owners of the property and their spouses
 - name of the school district where your primary residence is located
 - approximate date you purchased the property
 - names of the sellers (not required, but may help to expedite processing)
 - most recent school tax bill
 - address of any residential property owned in another state
 - legal name of the trust, if applicable
 - 2023 federal or state income tax returns for all owners and any owner's spouse who resides at the property. If any of these individuals were not required to file a 2023 income tax return, you will need to provide financial information for them.
