# Instructions

#### Who must file Form TP-125

If you will import more than 90 but not more than 360 liters of liquors into New York State during a one-year period for your personal use and consumption, you **must** file Form TP-125 to apply for a temporary license. You must receive your license **before** importing the liquors.

If you will import 90 liters or fewer, you are **not required** to apply for a temporary license.

If you will import liquors for sale, or import more than 360 liters during a one-year period for your personal use and consumption, you **must** register as a distributor of liquors using Form TP-215, *Application for Registration as a Distributor of Alcoholic Beverages*.

#### Liquors include:

- distilled or rectified spirits, alcohol, brandy, cordial (wine or liquor base), whiskey, rum, gin;
- all other distilled beverages containing alcohol, including all dilutions and mixtures of one or more of the above; and
- · wines exceeding 24% ABV.

### When to file this application

Apply for a license within 30 days of when you intend to import the liquors. Do **not** apply earlier than 30 days.

#### Required attachments

Proof of ID: You must provide a copy of a picture ID (with a signature and proof of age) with this application.

In the space provided on the form, enter the code for the type of identification you are providing.

#### Identification type code

| Code | Type                |
|------|---------------------|
| 1    | Driver's license    |
| 2    | Picture ID          |
| 3    | Passport            |
| 4    | Picture credit card |
| 5    | Green card          |
| 6    | Other               |

#### **Transporter information**

If you are not transporting the liquor, enter the transporter's information. Otherwise, leave blank.

Indicate the method of transportation, such as **car**, **van**, **train**, **plane**, and so on.

If you are using an SLA permitted transporter or licensee, enter the SLA number, if known.

## **Destination of liquor**

Enter the destination address of the liquor. If it is the same as your address entered above, enter **same**.

#### **Supplier information**

If you know the supplier's information, enter it. Otherwise, leave blank.

#### Conversions

1 gallon = 3.785 liters

1 half gallons = 1.8925 liters

1 quart = 0.946 liters

1 fifth = 0.757 liters

1 pint = 0.473 liters

1 half pint = 0.2365 liters
