| 12 -15 | Full receipted tuition amount \$100 | 2 overnights, meals, mileage, tolls |
| 6 - 9 | One half receipted tuition amount \$50 | 1 overnight, meals, mileage, tolls |
| 3 | No tuition | No overnights. Only allow travel meals, mileage, tolls |

Vouchers must be received by ORPTS within 30 days of the conference. Reimbursement rates for Oneida County Hotel = \$89 per night (must have itemized receipt); Meals = \$10 for breakfast and \$41 for dinner (lunch is not reimbursable). Mileage = \$.54 per mile and tolls. Rates are subject to change. Reimbursement will be provided from the Second Training Period (August 1 – November 30). Reimbursement for continuing education may be prorated. Rules allow ORPTS to reimburse a percentage of the expenses when funds are insufficient to cover all expenses.
